

Year 2014 marked yet another busy period for the CPD. Whilst the regular programmes were continued in full swing, the year also saw introduction of a number of new initiatives and activities involving both research and outreach.

The first CPD Anniversary Lecture, delivered by *Professor Louka Katseli* on the theme of "Recent Fiscal and Labour Market Adjustment Experiences in Europe and Lessons for the Low-Income Countries" was, no doubt, one of the key milestones for the CPD in 2014. CPD plans to make the Lecture an annual event.

A public dialogue was held under the "Post-Rana Plaza Monitoring: A Civil Society Initiative" of the CPD this year, to commemorate the first anniversary of the Rana Plaza tragedy of 24 April 2013. The initiative was implemented with support of several partners who joined the monitoring platform at CPD's invitation. The exercise received appreciation

and attention of concerned stakeholders as an excellent endeavour to ensure transparency and accountability in the delivery of post-Rana Plaza actions and promises.

Colleagues at the Research and Dialogue and Communication Divisions of the CPD kept themselves busy throughout this year to implement CPD's multifaceted activities. Some of these included monitoring the dynamics of Bangladesh's major macroeconomic parameters, analysis of fiscal and monetary policies and sectoral developments and tracking implementation of the FY2014-15 budget. Various activities planned as part of the Think Tank Initiative (TTI) work programme was also successfully implemented in this year. An important pioneering work of the CPD in this period was estimation of women's contribution to the Bangladesh GDP which involved a largescale household survey.

As the Annual Report will bear out, in 2014 CPD was also able to further strengthen its collaboration and partnerships with a number of globally leading think tanks and international and bilateral organisations.

A number of events and activities were carried out under the aegis of the two global networks which are being hosted by the CPD at present. A publication pioneering titled Programme of Action for the LDCs (2011-2020): Monitoring Deliverables, Tracking Progress" was prepared under the LDC IV Monitor programme; the publication was subsequently launched in New York. As part of the work plan of the Southern Voice on Post-MDG International Development Goals initiative, a number of research works were carried out and various events were organised in Bangladesh and abroad to emphasise the importance of South-South Cooperation and focus implementation-related challenges of the Sustainable Development Goals (SDGs) at the country level.

I would like to take this opportunity to register my deep gratitude to the Board of Trustees of the CPD and all my colleagues for what we have been able to accomplish in 2014. 




Management & Implementation Committee (MIC)

The MIC meets on a regular basis to review the progress of research and dialogue activities, and discuss future plans of the CPD. The committee is also mandated to take decisions on daily administrative and management issues. A total of 25 meetings of the MIC were held in 2014.

Research Management Committee (RMC)

The RMC works to ensure proper planning and implementation of CPD's various research programmes. Chaired by the Head of Research, the RMC includes mid to senior level CPD researchers as its members. The RMC takes stock of progress in research work, discusses research proposals, and deliberates on CPD's research collaborations and partnerships. It is the RMC's task to design a research strategy for CPD to submit before the BoT for consideration and approval. During 2014, the RMC met on 4 occasions.

Review, Coordination & Planning (ReCAP)

The ReCAP body is comprised of all the CPD staff as its members. ReCAP meetings provide an opportunity for the CPD staff to discuss issues pertaining to research dialogue, administration or any other institutional matters. Seven ReCAP meetings were convened during 2014.

MACROECONOMIC PERFORMANCE ANALYSIS

CPD has been analysing performance of key macroeconomic parameters of Bangladesh and providing stakeholders with perspectives on both strategic and policy issues and current development status since 1995. Under the flagship programme Independent Review of Bangladesh's Development (IRBD), CPD has been conducting periodic review of the state of Bangladesh economy along with preparing recommendations and proposals for country budget based on the findings, and analysing the national budget, with both immediate and comprehensive readings, with an inclusive objective to have practical reflections of country needs. The economy has lost its growth momentum over the corresponding period, because of disruption driven by political confrontation. Political turmoil in 2014 resulted in supply chain disruption, transport system breakdown, raising the cost of doing business, delaying shipments and undercutting profits.

State of the economy report of the first half of the FY2014 suggests that ADP implementation has been sluggish due to various internal and external reasons. Forty two out of the total of 54 ministries, rate of implementation was above the average in case of 29 ministries while the implementation record of rest of the ministries was below the average. CPD forecast said public expenditure growth for FY2014 will be to a higher tune of 27.7 per cent over the actual expenditure in FY2013. In FY2013, it was only 14.3 per cent higher compared to the same of FY2012.



CPD undertook a programme titled 'Post-Rana Plaza Monitoring: A Civil Society Initiative' following the collapse of Rana Plaza. As a follow-up activity of the programme a dialogue on "Rana Plaza Tragedy and Beyond: An Update on Commitments and Delivery," was held on 26 January 2014, in partnership with a number of civil society organisations and eminent citizens in Bangladesh. CPD dialogue highlighted that proper identification of victims and the status of delivery of compensation for the affected and their dependents have not been up to expectation despite efforts from different quarters, including government and RMG owners. Again on the 23 April 2014 a follow-up study titled "One Year after the Rana Plaza Tragedy: Where Do We Stand? The Victims, the Sector and the Value Chain" was presented by Dr Khondaker Golam Moazzem, Additional Research Director of CPD at BRAC Centre Inn Auditorium.

CPD observed that the unpaid work performed by women does not fall within the organised market economy of the country and is not accounted in the national income. Activities such as domestic labour and care providing facilities form insubstantial value and social capital that can add substantially to the GDP of a country. More wage-based work opportunity in formal

sector is the key to making women's unaccounted contribution more visible in the society. Such valuable observations were shared during dialogue titled on "How much Women Contribute to the Bangladesh Economy: Results from an Empirical Study," jointly organised by CPD and Manusher Jonno Foundation (MJF) on 25 October 2014.

Protecting GEOGRAPHICAL INDICATION Products





Recognising that the traditional art of weaving Jamdani muslin in Bangladesh was included in UNESCO's list of the "Masterpieces of the Oral and Intangible Heritage of Humanity" in 2013, CPD also urged the government to operationalise the Geographical Indication Act to claim the authenticity of Jamdani as a Bangladeshi heritage product with Geographical Indication (GI). CPD organised a dialogue on "Protecting Geographical Indication Products in the Context of Bangladesh and the Way Forward," organised by CPD and National Crafts Council of Bangladesh (NCCB) at CIRDAP Auditorium on 17 June 2014.

As part of emphasising on participatory and credible national election, reaching out to the local community, policy-oriented civil society, private sector and political opposition CPD dialogue on the study "Political Parties and Democracy in Bangladesh," was held on 17 May 2014 where it was observed that democratic practices and participatory culture must be revived within the political parties in order to achieve transparent and stable democratic governance in Bangladesh. CPD Distinguished Fellow Professor Rounaq Jahan drew upon the evolution of political parties in Bangladesh and the challenges that impeded democratic practices.

VAT and SD ACT 2012

CPD organised a roundtable discussion on "VAT and SD Act 2012: Concerns and Implementation Challenges" on 10 December 2014 where CPD urged for new reform agenda should safeguard the welfare of certain sectors with a view to supporting investment, growth and employment, and promoting social equity and economic justice by expanding the social safety net programmes.

KEY POINTS

- Value Added Tax and Supplementary Duty Act must be informed by equity concerns
- > Institutional capacity of relevant government agencies should be strengthened
- Implementation of the Act should benefit government and ensure tax justice for entrepreneurs and consumers



With a view to be shared with experiences and knowledge of salient experts CPD organised its first Anniversary Lecture in 2014 – the year of 20th foundation anniversary of the organisation. Dr Louka Katseli, Professor of Economics at the National Kapodistrian University of Athens, Greece addressed the Lecture titled "Recent Fiscal and Labour Market Adjustment Experiences in Europe and Lessons for the Low-Income Countries" on 18 November 2014 in Dhaka. In the Lecture Dr Katseli, an expert on international economics and development policy, former Director, OECD Development Centre, Greece's former Minister of Labour and Social Security and former Minister of Economy, Competitiveness and Shipping, emphasised on designing new global financial system that could safeguard interests of low-income countries.

- Implementing a domestic transformative strategy
- Develop new sectors, products and services
- Diversifying Bangladesh's economy beyond textiles
- Undertaking governance and institutional reforms
- Finance infrastructure by mobilising trade and domestic taxes
- Building partnerships for change at national, regional and global levels
- Shaping and investing on governance, infrastructure, human capital
- Introducing appropriate incentives for private sector mobilisation
- Designing effective social protection systems and ensuring policy coherence.



CPD observed that Bangladesh will need to diversify its export basket in order to enhance export competitiveness and take full advantage of the duty-free market access (DFMA) offer of India to SAARC LDCs. Deepening bilateral relationship with India covering the spectrum of trade, investment, transport and people-to-people connectivity is also crucial for Bangladesh to realise the potential opportunities emerging from the DFMA. The observations were surfaced at the CPD dialogue on "Utilising Indian Market Access Offer through Promotion of Trade Facilitation" on 22 April 2014 in Dhaka.

With score 3.72 out of 7, Bangladesh ranked 109th among 144 economies.

BUSINESS ENVIRONMENT IN BANGLADESH AND GLOBAL COMPETITIVENESS REPORT 2014-15

CPD expressed concerns on business environment and prevailing investment-related challenges in Bangladesh at the CPD dialogue on "Recent Update on Business Environment in Bangladesh and Launching of Global Competitiveness Report 2014-2015" on 4 September 2014. The Global Competitiveness Report (GCR) defines 'Business Competitiveness' as "the set of institutions, policies and factors that determine the level of productivity of a country."

Mobilising additional public finance, particularly domestic revenue resources and concessional foreign assistance, improving the global governance and institutions will endow the ambitious goals of post-2015 international development agenda.

CPD: Advocating for Building Blocks in Trade and Cooperation

CPD has steered momentum for economic cooperation at regional level through its research and dialogue. Its efforts have aimed at creating a wider canvas of opportunities for cooperation in South Asia and South East in five key areas: (i) mobilising the necessary funds for building physical infrastructure; (ii) identifying and sequencing of priorities; (iii) cross-border coordination; (iv) building human resources to manage cross-border mega projects; and (v) building supply-side capacities to benefit from connectivity-driven regional market opportunities. These came from a CDP publication titled 'Connecting South Asia and

Southeast Asia: A Bangladesh Country Study'.

Considering India as major regional partner, trade facilitation is important for enhancing Bangladesh's export opportunities in the Indian market. Based on this backdrop, CPD has commissioned a study on "India's Market Access Offer Realising Potential Opportunities through Enhanced Trade Facilitation".

Major findings of the study recommended investment in land port and infrastructure development, Single Window facilities and electronic data interchange in simplifying inadequate customs and port facilities.

China's role in South Asia: SA countries need own 'balancing' act

CPD in Regional and Global arena Spearheading Cooperation and Opportunities



CPD has extended its reach by carrying the voice of low-income countries and the developing South to inform and influence global discourse on issues of concern and interest to our countries through LDC IV Monitor and Southern Voice on Post-MDG International Development Goals. CPD findings recommended LDCs to prioritise resource mobilisation for public and private investment, industrial and sectoral policies to channel resources into the most productive sectors, activities and macroeconomic policies which foster economic growth.







KEY RECOMMENDATIONS FROM THE DIALOGUE WERE:

- Develop framework to identify the basic principles, scope and modalities, instruments and triggers of SSC.
- Generate evidence of cooperation and strategic engagement.

In order to fully explore the scope of South-South Cooperation (SSC) and to help demystify some of its South Asian experiences, the Southern Voice on Post-MDGs initiated the dialogue on "Deconstructing South-South Cooperation: A South Asian Perspective." The National Council of Applied Economic Research (NCAER), New Delhi and CPD were partners of the Southern Voice on Post-MDGs in organising the event in New Delhi, India on 27-28 March 2014.





CPD and the Norman Paterson School of International Affairs (NPSIA), Ottawa, in association with Southern Voice on Post-MDGs, the UN Foundation and the William and Flora Hewlett Foundation organised two workshops on 14 and 15 October 2014 to bring country-level perspectives to discussions on the post-2015 agenda by assessing the implications of implementing the new agenda at the national level.

The Data Test team presented their findings to a wide range of stakeholders engaged in the post-2015 discussions and negotiations, including the UN Secretary General's Independent Expert Advisory Group on the Data Revolution, diplomats from UN Missions in New York and UN staff. The workshops provided an opportunity for experts from seven countries to share their experience and research findings with member states, think tanks, UN and civil society in the New York policy community, and to explore implications for the data revolution and for the post-2015 agenda more broadly.

RECAPTURING THE MOMENTUM IN THE POST-BALI PROCESS OF THE WTO

To determine the needs of LDCs, including Bangladesh, to reform domestic regulations in taking cognisance of changes in the global economy CPD, jointly with Friedrich-Ebert-Stiftung (FES), organised the dialogue titled "Recapturing the Momentum in the Post-Bali Process of the WTO," at Lakeshore Hotel on Sunday 22 November 2014.

CPD Executive Director Professor Mustafizur Rahman noted in his keynote WTO in the Post-Bali Phase: Whither LDC Issues? that LDCs have been taking advantage of the multilateral trading system but their concerns and interests are hardly being reflected and addressed in the WTO.

The dialogue led to the Dhaka Roundtable on "Reviving the Multilateral Trading System: Post-Bali Issues" on 23-24 November 2014 which was co-organised with the South African Institute of International Affairs (SAIIA).





The two important dialogues were organised by CPD in association with the DFID-ESRC Growth Research Programme (DEGRP) on 20 February 2014 in Dhaka. These two dialogues were focused on Bangladesh's garments and agriculture sectors to discuss the challenges and solutions for economic transformation and growth.

Having the Hon'ble Minister for Commerce Mr Tofail Ahmed, MP as the Chief Guest at the first dialogue titled "Bangladesh's Garments Sector: Upgradation and Structural Transformation" asserted the needs in textile and garments sector of the country.

Panel Presenters Dr Dirk Willem te Velde, Head of Programme, International Economic Development Group, ODI recommended favourable changes in public policy, and incentives for Bangladesh's RMG

industry which has an export value greater than the individual GDP of some 90 countries. Another Panel Presenter Dr Christopher M Woodruff, Professor of Economics, University of Warwick emphasised on the requirement of innovations in production process in factories as goods become more complex.

The second dialogue of the day titled "Bangladesh's Agriculture and Structural Transformation" focused on country's needs to prioritise agricultural marketing and labour productivity to raise agricultural productivity where Mr



A H M Mustafa Kamal, MP, Hon'ble Minister for Planning, GoB attended as the Chief Guest.

Keynote presenter Dr Stephen Wiggins, Research Fellow, Agricultural Development and Policy, Overseas Development Institute (ODI) argued against common misperception that 'agricultural productivity is stagnant, and is difficult to raise'. He stressed that agricultural productivity can grow faster than the manufacturing sector.





In association with European Report on Development (ERD) 2014, CPD organised a workshop on "Financing and other Means of Implementation in the Post-2015 Context" in Dhaka on 19 February 2014.

The report aimed to provide a framework for discussions on bringing the finance and post-2015 goal setting processes together. It was also focused to feed into the synthesis of all the processes by late 2014 for a post-2015 agreement that would be adopted in September 2015.

Dr Dirk Willem te Velde, ERD 2014 Team Leader briefly dwelt on the ERD 2014 and financing in the post-2015 context. CPD Distinguished Fellow Dr Debapriya Bhattacharya, also the Chair of Southern Voice on Post-MDGs, as a Core Team Member of ERD 2014, shed light into the country illustrations on Bangladesh, Ecuador, Indonesia, Kenya, Mauritius and Moldova.
