<u>Centre for Policy Dialogue (CPD)</u>, a policy-influencing think tank in Bangladesh, is looking for proposals from an established vendor to provide video recording and live streaming services, including necessary equipment and manpower to conduct events across the country. The service provider should ideally be in a position to offer a service that will include:

- Video recording facilities
- Online video editing panel
- Capacity to connect with the Zoom Meeting Service with the live video feed
- Ensuring internet connection at event venues (including at district-level)
- Sound system facilities
- Mobile hard disk for video archiving
- A team of necessary technical persons to manage the video service who will travel outside Dhaka (any district headquarter) in their own travel and stay arrangements

Event and service information

CPD, as part of its regular activities is going to organises a dialogue at Pirojpur, Bangladesh. In the present COVID-19 situation, these events will take place partial virtually. A part of the guests will be connected from Dhaka or their own respective locations, and the guests at the local level will join the event through video conferencing from a particular venue point.

It is in this connection the above-mentioned service is sought. Two hired cameras will cover the event at the local-level venue. One video stream feed will be sent to a conferencing call application (Zoom Meeting Service). The audio of the programme will also be connected to the video using the sound mixer. The selected service-provider will have to ensure best possible internet connection at the venue. Its team must consist of camera operator(s), editing professional and any other technical person(s) required to manage this full execution.

The vendor is also required to conduct a trial run with CPD before the event.

Venue location: Pirojpur.

Scope of work for the service-provider

The service-provider is expected to arrange the above-mentioned equipment and a team of professionals who would travel to the Pirojpur and manage the video conferencing part from there. The breakdown activities will involve:

- Record the full event and send a video feed to the video conference during the event.
- Ensure necessary sound facilitates at the event.
- Ensure that the audio is synced with the video feed for the video conferencing.
- Deliver the footage from both the cameras to CPD in a hard-disk within seven (7) working days after the event.
- Arrange the travel, accommodation and food of the travelling persons which will be billed to CPD as part of the full cost proposal.
