# **Terms of Reference (ToR)**

# Centre for Policy Dialogue (CPD)'s documentary video

#### Introduction

Centre for Policy Dialogue (CPD) seeks to be the leading institution for in-depth research and dialogue to promote inclusive policymaking in Bangladesh, and strengthen regional and global economic integration. CPD was established in 1993 with the vision of creating an inclusive society based on equity, justice, fairness and good governance.

CPD has undertaken a project titled "Advancing Responsiveness and Accountability through Citizen Engagement in Bangladesh", supported by the United Nations Democracy Fund (UNDEF). The project activities will provide a platform to the citizens' for claiming delivery of the election pledges of the incumbent government through evidence-based research and subnational and national dialogues. The objective of the project is to achieve enhanced civic participation in the democratic process within the framework of Sustainable Development Goal (SDG) 16 to ensure the delivery of electoral pledges of the government.

Three expected outcomes of the project include: 1) articulated knowledge and expression of citizens' perspectives on the delivery of election pledges; 2) enhanced participation of the citizens' in policy discourse; and 3) policy actions initiated by the government reflecting citizens' perspectives on the delivery of election pledges in the three thematic areas—**Education, Gender Equality and Decent Employment**.

The activities of the project include:

- Three (3) brainstorming sessions (virtual)
- Ninety (90) Focus group discussions (FGDs) at the local level
- Five (5) subnational policy dialogues (in-person)
- One (1) workshop with the members of the national parliament
- One (1) national conference

### Purpose of the video

CPD is looking for a professional visual storyteller to narrate their works through one (1) video. The materials aim to the following:

- 1. Introduction of the project
- 2. Mission, vision, objectives and target audience of the project
- 4. Highlighting the research and activities
- 5. Impact and recommendations

The purpose of the video is to ensure that the relevant stakeholders have a clear idea about the project and the output.

### **Target audience**

The user/audience of the film/documentary will be:

- Donor community

- Other development stakeholders (INGOs, national NGOs/program partners, civil society organisations, national and international forum, such as High Level Political Forum on Sustainable Development-HLPF and media )
- Government officials
- Political leaders
- Academicians and researchers

The video may be shared on CPD's social media platforms, thus, also requires the video to be communicable with the mass audience.

### Process and workflow

The process for creating the documentary will involve:

- 1. Development of the script/storyboard
- 2. Collection of previous footage from a mutual selection of activities/events from the past (CPD will provide the necessary footage)
- 3. Interviewing and capturing videos of senior professionals of CPD in Dhaka. Interviewing and capturing videos of others at the two (2) divisional headquarters located outside Dhaka
- 4. Short-listing voice artist(s) and conducting vocal takes along with audio mixing and mastering into the final version of the videos
- 5. Using copy-right free background music
- 6. Using of copy-right free images and graphics (if necessary) in the video
- 7. Sub-title in English (CPD will provide credit line)
- 8. Design of documentary screenplay
- 9. Final compilation and editing of the documentary

#### **Timeline**

Video/photoshoots and interviews will be done initially between the last week of July 2022, it might be re-scheduled if any significant disaster/situation happens. The video shoots will be done in Dhaka and in two (2) divisional headquarters located outside Dhaka.

### The vendor is also required to strictly maintain the deadline provided by the CPD.

Deadline for final video submission: **Sunday**, **21 August 2022** 

#### Other issues

- Each layer of the video production works will go through an approval process from CPD's end. Necessary adjustments are required at each stage accordingly.
- All design files will need to be submitted to CPD at the end of the assignment.
- Necessary documents for copyright of background music and any image/graphic content used by the vendor for the purpose of the video must be be provided to CPD.

  - A copy of the firm's acknowledgment receipt of the annual TAX return
