Centre for Policy Dialogue (CPD) is looking for proposals from experienced travel agencies to enlist them for purchasing air-ticket for a particular project. The service-provider should ideally be in a position to offer a package service that will include:

- 1. 20 roundtrip air-tickets (tentatively)
- 2. Able to upgrade ticket class and seats if required
- 3. Able to make alterations of the tickets if required

Scope of work for the selected travel agency:

In connection to the mentioned project CPD is planning to avail the services from the selected travel agent to purchase roundtrip air-tickets from various cities to Bangkok. Arrival date in Bangkok is Sunday, 12 March 2023 and departure date from Bangkok is Wednesday, 15 March 2023.

The responsibility of the selected travel agency will be to share tentative travel itineraries with best available quotation (as per requirement of CPD), purchase/issue the selected air-tickets for delegates, make alterations of the tickets if required (flight change/ seat upgrade/ upgrade class). As the delegates will be confirming their attendance on different dates, individual air tickets will be purchased as an when required. Direct flights are preferable. In case non-stop flights are not available, flights with one-stopover with 3 – 4 hours layover is preferable. Travel agent might require to hold the booking for 48 hours.

- 5. Agreement with selected vendor
