# Centre for Policy Dialogue (CPD) Power and Energy Study video Industrial Rooftop Solar: Connecting with Owners

#### Introduction

CPD Power and Energy Study has been conducting a series of evidence-based and policy advocacy research projects aimed at challenging the fossil fuel (coal, oil, and gas, including LNG) based energy structure from the perspectives of economic viability and environmental concerns. CPD Power and Energy Study has established the Private Sector Renewable Energy Forum (PSREF) to significantly accelerate the adoption of renewable energy within key industrial sectors in Bangladesh, particularly the ready-made garment (RMG) sector. PSREF is designed to be a crucial platform to address these challenges by fostering dialogue among industry players, financial institutions, government bodies, and development partners.

CPD, in collaboration with export-oriented industries including apparel, textile, agro-processing, and tea plantation, is working to promote renewable energy transition, especially solar transition, in the apparel industry. To make just transition to renewable energy CPD will be generating several knowledge materials for the respective industry stakeholders. The objective is to create a connection with the industry owners and decision makers of these export-oriented sectors by providing an easy-to-understand knowledge material (video) regarding the installation of the rooftop solar in the industrial infrastructure to comply with their decarbonization commitments, as well as to know alternative sources of energy-mix along with the existing fossil-fuel-based adaptation.

CPD is in need of a professional visual storyteller to narrate and promote the renewable energy transition adaptation among different stakeholders <a href="through1">through1</a> (one) video. The material aims to:

- 1. An introduction of the Renewable energy landscape for the export-oriented industries in Bangladesh in view of their decarbonaisation commitment as well as cost-effective energy sourcing outside fossil fuel,
- 2. Full installation process with basic information on the components of a solar power system for industrial infrastructure,
- 3. Financial benefits of solar adaptation in both enterprises and mid-tier factories,
- 4. Highlight of the broader commitment towards environmental justice.

## **Purpose of the videos**

The video aims to ensure that the relevant stakeholders have a clear idea of CPD's work and output. Thus, from the video, it is expected that:

1. The target audience will be able to have an idea of why solar system installation is important for the enterprise. The simple yet elaborate explanation of the installation process for everyone. The financial and environmental benefits of renewable energy adaptation for the respective industry.

# The process for creating the documentary will involve

- i. Development of the script/storyboard,
- ii. Confirmation of the script from the CPD,
- iii. Collaborating with ECP developers to capture the full solar installation process in a factory,
- iv. Computer-generated imagery (CGI) of the solar system's components,

- v. Highlighting the cost benefits of rooftop solar systems for both vertical and horizontal infrastructure,
- vi. Explanation voiceover of the installation process,
- vii. Compilation and editing of the video,
- viii. Final review and confirmation from CPD.

## **Working Location**

The filmmaker will shoot the video near Narayanganj/Ashulia/Gazipur (suggested by EPC developers) to capture the full process.

The filmmaker may require several days of outdoor shooting.

## **Working language**

The voiceover will be in Bangla with English subtitles.

The subtitles must be prepared by the filmmakers and must be approved by CPD.

## **Target audience**

The user/audience of the video will be:

- Industry owners/decision makers of the Apparel, Textile, Agro-processing, and Teaplantation sector

The video may be shared in various PEREF workshops and events; therefore, it also requires being communicable to a mass audience.

#### Main deliverables

The main deliverables of this visibility and communication material are:

1. A HD/4K quality video of maximum 2-3 minutes' organisational video as per the above requirements.

## Other deliverables

- Approved work plan for the tasks
- Script
- On-site filming
- Submission of rough cut
- Editing, adding subtitles, and incorporating changes according to CPD's feedback.
- Submission of the final cut
- Provision of the original editing file of the final video cut and provision of all raw footage for further usage
- Aired/Social media versions
- A master copy
- Copy of editable files
- An uploadable/ web version of the video

## **Video Ownership and Usage**

All videos will be the exclusive property of CPD, with unrestricted usage, reuse, reproduction, and sharing rights, and the contracting individual will not claim legal ownership or copyright over these videos, nor will they use, share, sell, exhibit, or barter any of the videos for any purpose, commercial or otherwise.

## **Proposal evaluation**

#### 1. Technical Evaluation

- The visual storyteller should have a professional experience of a minimum of three (03) years, preferably in a developing profession.
- The visual storyteller needs to demonstrate his/her/their work, preferably taken in diverse situations.
- The visual storyteller must be appropriately sensitive to gender, values, and norms of the community people, civil society, local administration, and policymakers.

## 2. Financial Evaluation

The applicants also need to submit a financial proposal highlighting the cost. CPD will only open the financial proposals from consultants whose technical proposals meet the above-mentioned criteria.
