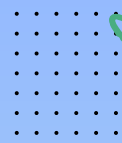

Project Overview



The Centre for Policy Dialogue (CPD), in collaboration with the Gates Foundation (GF), is implementing the project to strengthen Bangladesh's healthcare system by enhancing the Digital Public Infrastructure for Health (DPI-H) and empowering youth as key drivers of this transformation.

The project, to be implemented from September 2025 to March 2027, addresses the gap between youth education and public service innovation by equipping young people with the digital and policy skills needed to bridge innovation and implementation. This dual focus aims to improve health service delivery while creating meaningful opportunities for youth.

Recognising young people as both drivers of digital innovation and key beneficiaries of new opportunities within the health system, this project places youth engagement at the centre of successful DPI-H. By strengthening youth capacity in digital technologies and health policy, the initiative aims to improve the quality and reach of healthcare services while fostering more inclusive and sustainable economic development.

This project also tackles a vital issue in Bangladesh: the gap between young people's education and available employment in public service innovation. By focusing on DPI-H, a sector that needs both technological skills and health-system literacy, the project aims to create a generation of youth capable of bridging innovation and policy implementation. This synergy can optimise returns on investment in health service delivery and youth employment, thereby supporting Bangladesh's progress towards SDG 3, SDG 4, and SDG 8.
